Financial Investments Inc. (FII) Continues with Consistent Positive Returns

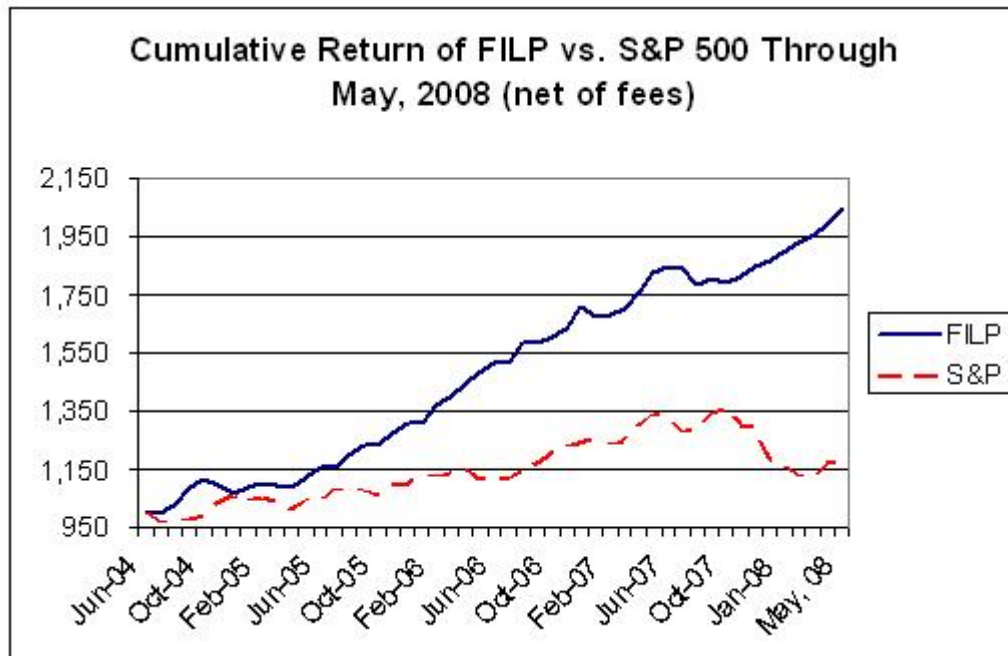

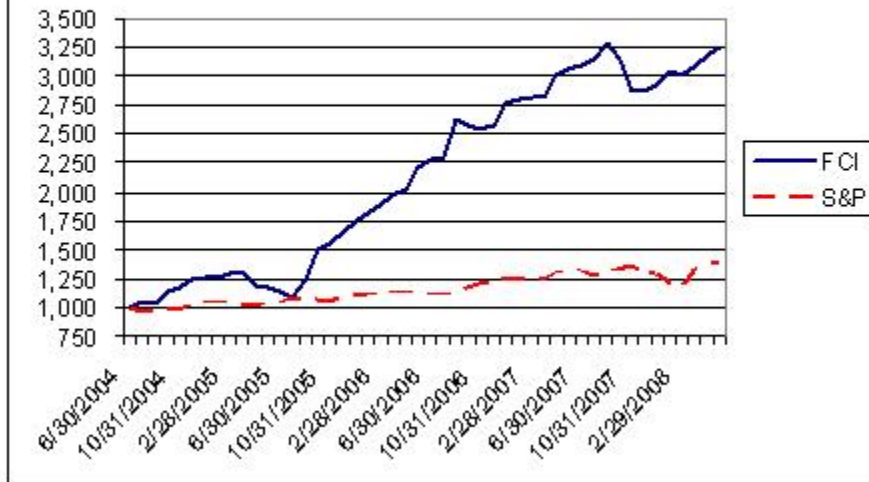
